BEHAVIOR CODE FOR SCHOOL-SPONSORED TRIPS

1. Students are representatives of this school. They are expected to be on their best behavior at all times. Anything less is unacceptable.
2. If a student behaves in a manner that is extremely disruptive, detracts from the enjoyment of the group as a whole, or is illegal, a parent(s) will be contacted to pick up their child, no matter where the group is at that time, and the parent(s) will be responsible for transporting their child home.
3. There will be consequences for unacceptable, or illegal behavior upon return to the school, in addition to those imposed upon the student at the time of the incident. While on a fieldtrip the student will be held accountable to the student handbook and the policies of the school district.
4. Unacceptable or illegal behavior on the part of a student may result in their forfeiting the privilege of attending any future school-sponsored trips.
5. Any prepaid fees that are nonrefundable to the school are also nonrefundable to the student.
6. Students are expected to practice common safety precautions at all times:
 - Never go anywhere alone
 - Don't talk to strangers
 - Don't display your money
 - Stay close to the group
7. Students are expected to be polite and respectful to the chaperons at all times. They will follow the rules of the trip and the directions of the chaperons at all times.
8. Neither the school district, nor its personnel are responsible for the actions/behavior of the students. Only the students are accountable for their own behavior.
