CALL TO ORDER – ROLL CALL

Member Shockley made a motion to approve the FY21 Amended Budget. The motion was seconded by Member Williams. Voting “Yea” were Buhl, Shockley, Therry, Tisdale and Williams. Motion carried 5-0.

Member Shockley moved to terminate employment of cafeteria workers, Joyce Ernst and Joan Wodstrchill effective June 23, 2021 due to the Rogers school closure, their relative seniority and lack of cafeteria certification and directed the Superintendent to provide written notice of the Board’s decision to the employee. Member Tisdale seconded the motion. Voting “Yea” were Buhl, Shockley, Therry, Tisdale and Williams. Motion carried 5-0.

Member Tisdale made a motion to employ employee Sally Sonderman, Custodian; Cody Stewart, P.E. teacher at Marquette; Jacob Ewing, Georgetowne Basketball Coach for 2021-2022 and Myles Stambaugh, Athletic Director for 2021-2022 school year. Member Therry seconded the motion. Voting “Yea” were Buhl, Shockley, Therry, Tisdale and Williams. Motion carried 5-0.

DISCUSSION ITEMS

Changes to Student Handbooks for the 2021-2022 school year – Final approval of the handbooks will be at next month’s meeting.

Updates on Summer Projects – Mr. Sondgeroth gave an update on the progress of the summer projects in each building. Rogers school will be completed by the end of the week and will be ready for Tazewell Mason to move in. Black top upgrades have begun at Marquette School. The library at Marquette is almost complete. The downstairs rooms at Georgetowne are almost done. The gym floor has been sealed. The asphalt project will begin at Georgetowne and Rogers when completed at Marquette.

Discussion of Scenarios for the start of 2020-2021 school year – Mr. Sondgeroth discussed with the Board the state requirements to begin school. There are different options to hold classes and remote learning.

FY21 Budget Summary for May – Mr. Sondgeroth shared a copy of the FY21 budget summary report from the month of May with the Board.

Review of Bus Pass Survey – Mr. Sondgeroth discussed with the Board the summary of the responses he received from the survey.
