Facility Updates -

Superintendent Lindsay informed the board that Veregy, MSI and the architect are working on the HVAC system. The system currently is set to cooling mode and cannot be manually turned on, this would void the warranty. Warm days are needed to start the system and Mrs. Lindsay was assured the system will be cooling by the time warmer weather is here.

Bridge- Superintendent Lindsay informed the Board that the engineer working on bridge is leaving the Farnsworth. Bridge work is to start in May.

Superintendent Lindsay informed the Board that the architect will work on the exterior doors, not the main doors, for replacement. Doors will be replaced one at a time. Work will start spring of next year.
